TARIFFS ON MATERIAL IMPORTS

U.S. TARIFFS ON STEEL (25%) AND ALUMINUM (10%) imports began in May 2018. Imports of these metals to the United States from China, Canada, Mexico and the EU are among the most affected.

Meanwhile, tariffs were announced on a host of other materials from China in 2018, including many components used in the sign, graphics and visual communications industry. All of these tariffs may be disruptive to our industry's supply chain due to a limited domestic supply of certain products.

Serious regulatory reform is needed, and ISA supports easing the bureaucratic burden on the sign, graphics and visual communications industry by calling on Congress to pass legislation consistent with our industry's needs.

DEPARTMENT OF LABOR (DOL) RULES ON OVERTIME PAY AND JOINT EMPLOYMENT have met with stiff resistance from the business community since they were announced in 2016, which is why the DOL is expected to release new versions of these major regulations in early 2019.

The DOL will likely end the expansion of the number of workers covered by the federal **overtime rule**. It is also expected to provide an updated overtime threshold.

When it comes to **joint employment**, ISA recently submitted comments to the DOL supporting a higher standard of "direct control" between sign manufacturers and installers, and sign franchisees, so that they can better run and grow their business.

SIGN CODE TRENDS

VEHICLE WRAPS are growing in popularity, which has spawned new questions and enforcement issues for local governments. These are not traditional signs.

Communities are starting to address vehicle wraps in sign regulations, where the focus of standards is on the parking or location of the vehicle, rather than the size of the "sign."

In some cities, vehicle wraps are permitted "but only if the primary purpose of such vehicles is not for the display of the signs thereon."

SAFER & SMOOTHER ELECTRIC SIGNS

ISA and sign industry experts have 11 proposals pending before Code Making Panel 18 for the 2020 National Electric Code (NEC), which will help improve safety while accessing or servicing electric signs and will better accommodate LED retrofits of existing signs.

The NEC 2020 is scheduled to be published in August 2019.
